1. What Are Cookies?

Cookies are small text files that a website places on your computer, tablet, or mobile device when you visit it. They are widely used to make websites work more efficiently, enhance user experience, and provide anonymous information to the website owners.

This Cookie Policy explains the types of cookies we use, why we use them, and how you can control them.

2. Legal Framework

We comply with:

- **Greek Law 3471/2006** (implementing the EU ePrivacy Directive)
- **General Data Protection Regulation (GDPR) (EU) 2016/679**

Under these laws, we must obtain your **explicit, informed consent** before placing any non-essential cookies on your device. The only exception is for **strictly necessary cookies** that are essential for the basic functioning of our website (e.g., shopping cart, security).

3. How We Obtain Your Consent

When you first visit our website, a cookie banner will appear. The banner allows you to:

- **Accept All** non-essential cookies
- **Reject All** non-essential cookies

- **Customise Settings** – you may grant or deny consent for each category of cookies separately

You can change or withdraw your consent at any time by clicking the “**Cookie Preferences**” link in the footer of our website. Withdrawing consent does not affect the lawfulness of processing based on consent before its withdrawal.

We do not use pre-ticked boxes, scrolling, or continued browsing as a form of consent.

4. Types of Cookies We Use

We use the following categories of cookies on our website:

Strictly Necessary Cookies	Essential for navigation, shopping cart, and security. Without these, the website cannot function properly.	Yes	Exempt from consent (GDPR Art. 6(1)(f) – Legitimate Interest)

Analytics / Performance Cookies	Collect anonymous data about how visitors use our website (e.g., pages visited, time spent). We use Google Analytics for this.	Yes	Consent required (GDPR Art. 6(1)(a) & Law 3471/2006)

Category	Purpose	Do We Use These?	Legal Basis
Marketing / Targeting Cookies	Deliver relevant advertisements and measure ad campaign effectiveness.	No (currently)	N/A

5. Third-Party Cookies

Some cookies on our website are placed by third-party services. We currently use:

These third-party cookies are only placed after you give your consent. We have signed appropriate data processing agreements with Google.

6. Managing and Deleting Cookies

You have full control over cookies. You can:

- **Use our “Cookie Preferences” link** (in the website footer) to change your consent settings at any time.
- **Adjust your browser settings** to block or delete all cookies (including strictly necessary ones). However, blocking essential cookies may cause parts of our website to stop working.

7. Your Rights Under the GDPR

- **Right of access** – request a copy of the personal data we hold about you.
- **Right to rectification** – correct inaccurate data.
- **Right to erasure** – request deletion of your data, subject to legal obligations.
- **Right to restrict processing** – limit how we use your data in certain circumstances.
- **Right to data portability** – receive your data in a machine-readable format.
- **Right to object** – object to processing based on legitimate interests.
